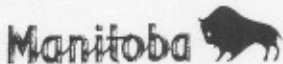

	<p>WHEREAS Manitoba Child Care Program (MCCP) has received information from the City of Winnipeg Fire Inspector, that during the annual inspection of the group child care home, incidents were observed whereby children were not being properly cared for and not provided adequate supervision, the particulars of which are as follows:</p> <p>On Monday, June 14, 2010 at approximately 12:30 p.m. the Fire Inspector observed two children (one and half years of age and two years of age) in playpens in the furnace room. The playpens were beside the furnace blocking the second door and one of the playpens had a crib mattress on top of it. When Ms. Brigitte Richardson, a licensee, was questioned as to the reason a mattress was placed over the playpen, she responded it was because the child kept climbing out and this would keep the child in. The two doors to the furnace room where closed and a dog was also in the room. There was no licensee present in the room with the children.</p> <p>In addition, two children, approximately, two to three years of age were sitting in highchairs in the open area level looking at books while the remainder of the children were laying down for nap in the same space. Ms. Richardson described the two children in highchairs as "rambunctious ones who won't sleep."</p> <p style="text-align: right;">2/7</p>

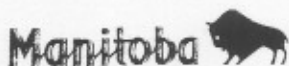

	<p>During the fire inspection, one licensee was in the basement with all of the children and the other licensee, Mr. Kevin Richardson was on the main floor, resulting in more than the allowable number of children in the care of one licensee. The duration of the inspection was approximately 20 minutes.</p> <p>In reviewing the group child care home's licensing information it was noted that one licensee, Ms. Ainslee Hanson, currently fails to meet the requirement for completion of a 40 hour course within 12 months of issuance of a licence.</p> <p>This is in violation with the following section of <i>The Community Child Care Standards Act</i> which states:</p> <p><b>Responsibility to provide proper environment</b></p> <p>"3(1) Every person providing child care shall at all time provide an environment that is conducive to the health, safety and well-being of the children."</p> <p><u>AND</u>, of the following sections of <b>Manitoba Regulation 62/86</b> which state:</p>

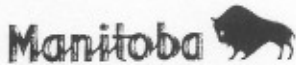


