Please forward a photocopy of your driver's license, Status Card or any other government issued photo I.D. as well as a photocopy of a Birth Certificate or Medical Card for all children that will also be visiting. Applications which are unsigned or have no accompanying ID, cannot be processed.
Just a few rules you should be aware of:
There is no smoking in the facility and on all facility grounds. Please leave all tobacco products, cell phones, electronic devices, cameras, purses and all valuables in your vehicle. You are not able to give or leave any property for the inmate. Only pre-approved items will be accepted. A maximum of two adults and two children are permitted to visit at one time. Inmates are permitted one visit per week (7 days). Visitors wearing inappropriate clothing or under the influence of drugs or alcohol will not be permitted to visit.

COVID 19 Guidelines

All visitors over the age of 12, are required to have been fully vaccinated for COVID-19 (Fully vaccinated, meaning, the person(s) visiting have received the full series of a vaccine or a combination of vaccines accepted by the Government of Canada (Pfizer-BioNTech, Moderna, AstraZeneca [COVISHIELD] and/or Janssen [Johnson and Johnson]) for a minimum of 14 days prior to last vaccine dose.

NOTE

All visitors will be asked to provide your Manitoba Government issued Quick Response (QR) Code and photo Identification when you arrive on the property of Milner Ridge Correctional Centre. Minors without Photo ID must provide a birth certificate or medical card for identification. Failure to provide these documents will result in your visit being cancelled. All visitors will be required to wear a mask upon entering Milner Ridge Correctional Centre and continue to wear the mask for the duration of the visit. Failure to wear a mask will result in the termination of your visit.

<p>I understand that Manitoba's Department of Justice (Corrections) has the sole right to determine my suitability as an inmate's visitor. I further understand that approval of visiting privileges is conditional upon satisfactory results of security screening. I hereby consent to and authorize the Government of the Province of Manitoba to undertake a criminal records check and to confirm with any police agency the details of any convictions which may have been made against me for any offence under any federal or provincial legislation as well as for any charge which may be outstanding against me under such legislation. I further hereby consent to and authorize any police agency to release to the Government of Manitoba such details of convictions and outstanding charges as aforesaid and in so doing this shall be their good and sufficient warrant, discharge and authority to do so. To this end, I certify that the information I have submitted is true and accurate to the best of my knowledge and I agree to notify institutional authorities immediately should there be any change to that information. I acknowledge that the submission of false or misleading information or the failure to advise of changes may result in denial or suspension of my visiting privileges for an indefinite period. Finally, I agree to observe all stated rules, regulations and policies while visiting this institution and understand that the failure to do so may result in suspension of my visiting privileges.</p>
