Mr. MAGUIRE – Legislative Assembly of Manitoba to request that the Minister of Infrastructure and Transportation consider abandoning the "Manitoba Freeway" proposal for the junction of PTH 1 and Virden's three intersections—particularly the King Street junction. Mr. WISHART – Legislative Assembly of Manitoba to request that the appropriate Ministers of the Provincial Government consider repairing St. Ambrose Provincial Park and its access points to their pre-flood conditions so the park can be re-opened for the 2013 season or earlier if possible. Mr. SMOOK – Legislative Assembly of Manitoba to request that the Minister of Health consider reopening the emergency room in Vita as soon as possible and commit to providing adequate medical support for residents of south eastern Manitoba for many years to come. Mr. EWASKO – Legislative Assembly of Manitoba to urge the Minister of Infrastructure and Transportation to recognize the serious safety concerns of Provincial Road 520 and to address its poor condition by prioritizing its renewal. (T. J. Johnson, B. Summerfield, B. Buck and others)
