Mr. BUSHIE moved:

Resolution No. 28: Calling on the Provincial Government to Stop Cutting Education Funding

WHEREAS adequately funded education supports the development of Manitoba's children and has the potential to break cycles of poverty, close the gap in social inequality, create a more inclusive society and much more; and

WHEREAS the Provincial Government has cut core operating funding for education by \$36 million since 2019; and

WHEREAS the Provincial Government underspent education by \$112 million in 2021-2022 alone; and

Thursday, November 3, 2022

WHEREAS the Provincial Government underspent strategic infrastructure investments in Education by \$108 million in 2021-2022; and

WHEREAS the Provincial Government has spent millions on consultants for Bill 64, a curriculum evaluation and an education funding review rather than investing in education; and

WHEREAS the province's share of education funding has fallen from 62.4% to just 56.4%, forcing school divisions to make cuts to programs and staff; and

WHEREAS school divisions have been forced to make cuts to programs that students rely upon such as all-day kindergarten, speech-language pathology, psychology and reading recovery; and

WHEREAS Brandon School Division and Seven Oaks School Division have been forced to cut 11 and 28 educators respectively; and

WHEREAS the Provincial Government has failed to listen to the concerns of Manitobans surrounding education funding cuts, and has continued to make cut after cut; and

WHEREAS the Provincial Government has failed to adequately support students and educators in the province, particularly in northern and rural Manitoba; and

WHEREAS these cuts put the quality of education in the province at risk.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba urge the Provincial Government to stop cutting funding for education and to invest in Manitoba's students.

Your Committee agreed to report this Bill with the following three amendments:

THAT Schedule A to the Bill (The Hospitality Sector Customer Registry Act) be amended by renumbering Clause 5 as Clause 5(1) and adding the following as Clause 5(2):

More than one person admitted to occupy lodging

5(2) If more than one customer is admitted to occupy the same lodging, the registry keeper must enter the information for only one customer.

THAT Schedule A to the Bill (The Hospitality Sector Customer Registry Act) be amended by replacing Clause 7 with the following:

Customer to provide identification

7 A customer must provide the prescribed identification in the following manner:

(a) in the case of a hotel, to the registry keeper, at the time the customer is admitted to occupy a lodging or at another prescribed time;

(b) in the case of an online accommodation platform, to the registry keeper or to the person prescribed to be acting on behalf of the registry keeper, at the time the customer is admitted to occupy a lodging or at another prescribed time;

(c) in the case of any other registry keeper, to the registry keeper, at the time the customer accesses the services provided by the registry keeper or at another prescribed time.

THAT Schedule A to the Bill (The Hospitality Sector Customer Registry Act) be amended in Clause 20(1) by replacing the proposed clause 20(1)(g) with the following:

(g) respecting the collection, use, disclosure and retention of information and records obtained under this Act;

(g.1) prescribing the persons who may act on behalf of a registry keeper and the duties of such persons;

The following petitions were presented and read to the Legislative Assembly of Manitoba:

Mr. KINEW – To urge the Provincial Government to respect the PUB's independent rate-setting process and to not increase the financial pressures Manitobans are currently facing and withdraw Bill 36.

Mr. MALOWAY – To urge the new Premier to financially assist the City of Winnipeg on building this three-lane bridge in each direction to maintain this vital link between northeast Winnipeg, Transcona and the downtown; to urge the Provincial Government to recommend that the City of Winnipeg keep the old bridge fully open to traffic while the new bridge is under construction; and to consider the feasibility of keeping the old bridge open for active transportation in the future.

Mr. MOSES – To urge the Provincial Government to immediately provide comprehensive and free healthcare coverage to all residents of Manitoba regardless of immigration status, including refugee claimants, migrant workers, international students, dependent children of temporary residents, and undocumented residents; to urge the Minister of Health and Seniors Care to undertake a multilingual communication campaign to provide information on expanded coverage to all affected residents; to inform all healthcare institutions and providers of expanded coverage for those without health insurance and the details on how necessary policy and protocol changes will be implemented; and to create and enforce strict confidentiality policies and provide staff with training to protect the safety of residents with precarious immigration status and ensure they can access health care without jeopardizing their ability to remain in Canada.

Mr. SALA – To urge the Provincial Government to respect the PUB’s independent rate-setting process and to not increase the financial pressures Manitobans are currently facing and withdraw Bill 36.
