Clerk of Committees (Ms. Patricia Chaychuk-Fitzpatrick): Order, please. Will the Standing Committee on Private Bills please come to order. We must proceed to elect a Chairperson. Are there any nominations?

Mrs. Shirley Render (St. Vital): I would like to nominate Jack Reimer.

Madam Clerk: Mr. Reimer has been nominated. Are there any further nominations? If not, Mr. Reimer, you are duly elected Chairperson.

Mr. Chairman: Order, please. This afternoon the Standing Committee on Private Bills will be considering the following bills: Bill 66, The Winnipeg Canoe Club Incorporation Amendment Act; Bill 32, The Mount Carmel Clinic Amendment Act; and Bill 67, The Salvation Army Grace General Hospital Incorporation Amendment Act.

No presenters have registered to speak on these bills. Accordingly, we will now proceed with the bill.

**Bill 66—The Winnipeg Canoe Club
Incorporation Amendment Act**

Mr. Chairman: Did the sponsor for Bill 66, Mrs. Render, have any opening remarks?

Mrs. Shirley Render (St. Vital): As you know, I am very pleased to be sponsoring the amendment to The Winnipeg Canoe Club Act. What the amendment seeks to do is to make very clear that the club is a not-for-profit corporation by providing that, upon dissolution of the club and after the payment of all debts and liabilities, the remaining property of the club should be distributed or disposed of to charitable organizations or organizations which are beneficial to the community. I would urge that all members support this amendment. Thank you.

Mr. Chairman: On Bill 66, we will first hear from Legislative Counsel.

Mr. Isaac Silver (Crown Counsel): This is Legislative Counsel's report on Bill 66 as follows:
