#### **CONDITIONAL USE ORDER**

Conditional Use Order No. CU 01-2017

WHEREAS, Sam Waldner (applicant) and Waldheim Colony (owner), of property legally described as Survey NE 20-10-3W, Cartier, MB in an "AG" Agriculture General Zone in the Rural Municipality of Cartier applied to the Council of the Rural Municipality of Cartier as follows:

To build a new poultry barn to allow for the expansion of their poultry operation with an increase in layers from 9,000 (75 AU) to 20,000 (166 AU) and an increase in pullets from 6,400 (22 AU) to 20,000 (66 AU) respectively, within an Animal Confinement Facility in an "AG" Agricultural General Zone

and after careful consideration of the application and any representations made for or against it, the Council of the Rural Municipality of Cartier in meeting duly assembled on July 25, 2017,

APPROVED the said application with the following conditions;
