Virtually all of the negative impacts of hog farming are related to animal wastes. (Actually it's not farming but more like a factory). Estimates show that a hog produces between 1 and 4 kg of waste every day, depending on its age and size. This amounts to anywhere between 2 and 8 tonnes of manure (including urine) daily on a farm with just 2,000 hogs. Liquid manure is first stored near the hog barns, either in a holding tank or in an open lagoon, and is eventually sprayed as fertilizer on nearby fields.

Another thing to consider is that farm animals are sentient beings, with intricate social relations and sophisticated psychological patterns. They may not be as intelligent as us, but they certainly know pain, fear and loneliness. They too can suffer. Thousands of sentient beings, each with complex sensations and emotions, live and die on a production line.

Fuelled by the meat consumer's ever-growing demand for cheap pork the question we need to ask is "what's the true cost of that bacon?". Consumers should consider not just animal welfare but also the quality of what you're feeding yourself and your family. Intensively reared, antibiotic-laden meat from stressed animals confined in high numbers in cramped indoor conditions — is simply not acceptable.




The total number of pigs on farms in mid-2015 was

2,995,000 head, up by 1.7% from a year earlier and only 0.03% below the July 1, 2007 record of 3,005,000 head.

On July 1, 2015, of the 2.676,000 pigs on Manitoba farms destined for market, 1,131,500 head or 42.3% were either new-born or weanling pigs weighing less than 23 kg. Almost half of these pigs weighed less than 7 kg. Many pigs weighing less than 7 kg are born and exported between quarterly Statistics Canada surveys so are never counted. About 497,300 of the pigs (18.6%) on farms July 1, 2015 weighed between 23 kg and 53 kg, of which about 10% were to

be exported. There were 562,300 head (21.0%) in the 54 to 80 kg category and 484,900 head (18.1%) in the 81+ kg category, almost all of which were fed to an average slaughter weight of over 122 kg.

Opposition to proposed hog barn

I am writing to express my extreme concern for the proposal that was received by the RM of Lorne from V.C. Hog Ltd. to build another industrial confinement facility in Swan Lake Manitoba. I am absolutely opposed to this for numerous reasons.

The amount of waste a new barn would generate is an estimated estimated 9-10 million gallons of raw sewage per year. The ecosystem in Manitoba is still suffering the consequences of unabated pig industry expansion, which has doubled the phosphorus load on Lake Winnipeg, and caused the growth of algal blooms that are killing Lake Winnipeg.

Footage from an undercover investigation at an Aborg pig farm revealed horrific abuse such as bleeding open sores, baby piglets being slammed to death on concrete floor, and pigs being murdered by bolt guns. This is considered standard practice. Yet, we all know that this is abuse, and it is wrong. Pigs are no different than your cat or dog. Pigs have the will to live, they feel love, fear, pain, and they don't want to die.

Communities that are located close to intensive animal agriculture operations face negative environmental impacts such as poor air and water quality - all of which can impact citizens quality of life. A recent study also showed that farm workers are more likely to carry and spread antibiotic resistant staph infections.
