# Rural Municipality of Cartier Under The Authority Of The Planning Act CONDITIONAL USE ORDER

#### Conditional Use No. CU 05-2021

WHEREAS, Leonard Hofer (applicant) and Starlite Colony (owner) of property legally described as Survey SE 4-10-2W (9091 Road 54 NW) Cartier, MB in an "AG" Agricultural General Zone in the Rural Municipality of Cartier applied to the Council of the Rural Municipality of Cartier as follows:

To allow for the addition of 85,000 broiler chickens into an existing mixed livestock operation, increasing the total Animal Units (AU) from 1,027 to 1,452 AU

and after careful consideration of the application and any representations made for or against it, the Council of the Rural Municipality of Cartier in meeting duly assembled on May 24, 2022,

### **APPROVED** the said application with the following conditions:

- 1. That the applicant adheres to all provincial government department regulations
- 2. A shelterbelt shall be planted on both the east and south sides of the barn for additional odour control
- 3. Flood mitigation must meet the provincial requirements.

Approval shall expire if not acted upon within 12 months of the date of making unless it is renewed prior to the expiry date at the discretion of Council for an additional period not exceeding 12 months.
