THIS LICENCE IS ISSUED TO:

**THE PROVINCE OF MANITOBA REPRESENTED BY THE MINISTER OF
HIGHWAYS AND TRANSPORTATION: "the Licencee"**

for the construction and operation of the Development being the upgrading of Provincial Trunk Highway #10 from south of Mafeking to north of the Red Deer River, located in the LGD of Mountain and Swan River and subject to the following specifications, limits, terms and conditions:

SPECIFICATIONS, LIMITS, TERMS AND CONDITIONS

- 1) The Licencee shall construct the Development in accordance with Sheets 1 and 2 of the *Department of Highways and Transportation Proposed Location Plan of PTH #10 From South of Mafeking to North of the Red Deer River, October 1989*, filed as part of the Environment Act Proposal, dated June 11, 1992.
- 2) The Licencee shall construct the Development in accordance with the methods outlined in Part "F" of the Environment Act Proposal, dated June 11, 1992.
- 3) The Licencee shall, during construction, adhere to the Manitoba Department of Natural Resources guidelines titled *Recommended Fish Protection Procedures for Stream Crossings in Manitoba*.
- 4) The Licencee shall not undertake any instream construction on the Red Deer River between the spring ice breakup on the Red Deer River and June 30th.
- 5) The Licencee shall ensure that all petroleum products used in the construction of the Development shall be handled, stored, collected and disposed of in accordance with Manitoba Environment requirements.
- 6) The Licencee shall arrange, prior to beginning construction, to have Manitoba Environment Park - West Region staff identify suitable areas for the storage and handling of dangerous goods.
