In accordance with the Manitoba Environment Act (C.C.S.M. c.E125)

THIS LICENCE IS ISSUED TO:

**THE PROVINCE OF MANITOBA REPRESENTED BY THE MINISTER OF  
HIGHWAYS AND TRANSPORTATION:  
The "Licencee"**

for the construction of the Development being a winter road located east of Lake Winnipeg beginning at Loon Straits and extending to the Bloodvein River subject to the following specifications, terms and conditions:

1. The Licencee shall construct the Development in accordance with the Environment Act Proposal of the *Proposed Winter Road Loon Straits to Bloodvein River Area*, dated December 18, 1993.
2. The Licencee shall, during construction, adhere to the general recommendations on design, construction and maintenance of stream crossings as specified in the Manitoba Department of Natural Resources guidelines titled *Recommended Fish Protection Procedures for Stream Crossings in Manitoba*.
3. The Licencee shall, during construction, use only ice and snow to fill in narrow rivers and streambeds.
4. The Licencee shall, during construction over streams where corduroy reinforcement is required, use only delimbed logs tied together to facilitate removal of the stream crossing in the spring.
5. The Licencee shall, prior to spring breakup, remove temporary stream crossings associated with Development.
6. The Licencee shall, prior to construction, obtain a permit for the removal of timber from the Development.

7. The Licencee shall, during construction, ensure that all fuel storage areas established for the construction of the Development are located a minimum distance of 100 meters away from all lakes and streams, and shall comply with the requirements of *Manitoba Regulation 97/88R* respecting *Storage and Handling of Gasoline and Associated Products Regulation*.
8. The Licencee shall, during abandonment of the Leyond River crossing, rehabilitate the crossing site in accordance with the 1986 agreement between the Parks Branch and the Department of Highways and Transportation.
9. The Licencee shall, during abandonment of the Bloodvein River crossing, consult with and receive approval from Parks Branch and Regional Department of Natural Resources staff with respect to the method of rehabilitation of the crossing.
10. The Licencee shall, during construction of the Development, notify Parks Branch and Regional Department of Natural Resources Regional staff in advance of any scheduled field inspections.

#### REVOCATION

If in the opinion of the Director the Licencee has exceeded or is exceeding the limits, or has not complied or is not complying with the specifications, terms or conditions set out herein, the Director may revoke, temporarily or permanently, this Licence.
