AN ORDER OF THE CLEAN ENVIRONMENT COMMISSION  
UNDER THE CLEAN ENVIRONMENT ACT

Re: The Clean Environment Commission and the Rural Municipality of St. Andrews, applicant,

WHEREAS pursuant to the provisions of The Clean Environment Act, the Rural Municipality of St. Andrews has submitted an application to the Clean Environment Commission to prescribe limits in connection with the operation of a waste disposal ground located on part of SW $\frac{1}{4}$  13-13-3E in the Rural Municipality of St. Andrews,

AND WHEREAS no representation was made to the Clean Environment Commission by any person who is or is likely to be affected by an Order of the Commission prescribing limits in connection with the said operation,

AND WHEREAS the Clean Environment Commission considered the application on the 14th day of May 1973,

IT IS HEREBY ORDERED THAT

1. The applicant shall ensure that within two months from the date of issuance of this Order, the wastes presently on the said site are redeposited in conformity with Clauses 2, 3, 4 and 5 of this Order.
2. The applicant shall ensure that wastes are deposited in trenches no deeper than 10 feet below grade.
3. The applicant shall ensure that wastes are covered with six inches of compacted earth at least every two weeks with the exception of the winter months.
4. The applicant shall ensure that when a trench is filled the wastes are compacted and covered with a minimum of two feet of compacted earth to a maximum finished elevation of eight feet above grade.
5. The applicant shall ensure that special wastes such as cars, farm machinery, household appliances, and other large metal objects are placed above grade in a separate section of the waste disposal ground.
6. The applicant shall ensure that no burning occurs on the site at any time.
7. The applicant shall ensure that the operation of the said disposal ground is supervised:

- (1) to ensure the orderly placement and confinement of waste, and



- (2) to prevent scavenging unless authorized by the applicant, and
  - (3) to control random dumping on the access road to the said disposal ground, and
  - (4) to carry out the other requirements of this Order as these apply to the day by day operation of said disposal ground.
8. The applicant shall ensure that the area be adequately fenced to meet the requirements of supervision and control, to prevent livestock from entering and to control wind blown trash.
  9. The applicant shall ensure that as any part of the said disposal ground is used up to finished grade it is landscaped and/or seeded or sodded to preserve and enhance the environment.
