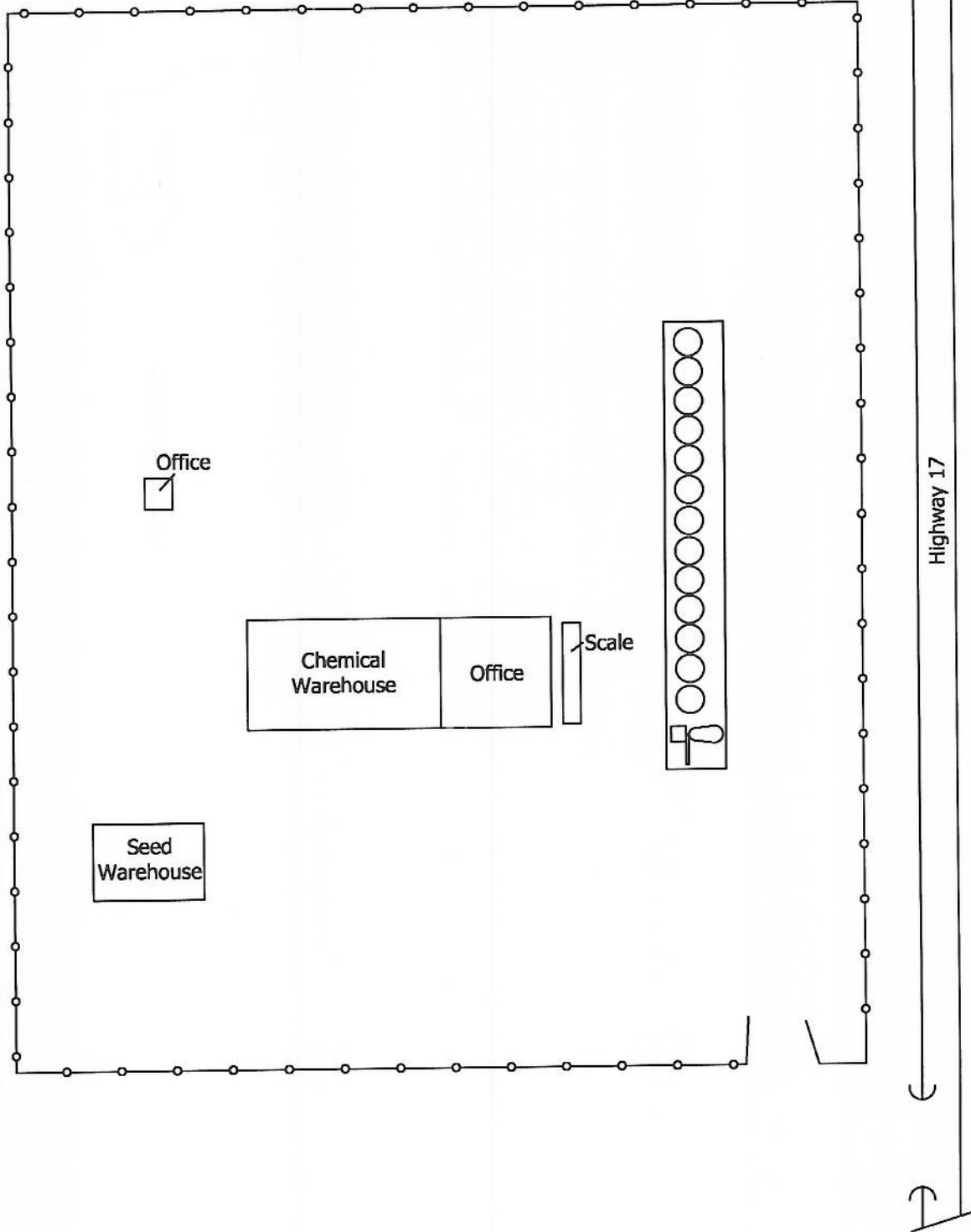
At this time, we also ask that you remove the NH3 Storage from the license as NH3 storage and distribution assets were removed from this location in the fall of 2014.
