

Municipal Waste Management Ltd. Emergency Preparedness Plan For Waste Oil

Waste Oil Spill and Accident Procedure

**DO NOT USE ANY CHEMICAL WITHOUT FIRST READING AND
UNDERSTANDING THE APPROPRIATE MSDS.**

1. If the spill is due to Vandalism and/or Theft, which may include breach to the containment of the product, call 911 immediately to insure that the incident is reported. If emergency personnel say that you can proceed follow guidelines listed below
2. Warn personnel in the area and evacuate the accident site if necessary.
3. Ensure injured or contaminated personnel receive prompt first aid/medical treatment. Remove contaminated clothing immediately. If eyes are contaminated, rinse thoroughly under running water for a minimum of 15 minutes and seek medical attention. Consult the MSDS for proper first aid treatment.

The first aid kits are located in all the trucks and in the bathroom of the main shop
The nearest first aid or medical help for the area is Souris Hospital located 6 miles
South of the Landfill location.

The eyewash station is located in the main shop on the north wall.

4. If the chemical hazard has the potential of endangering other individuals or other areas call 911 or the designated Emergency response System activation number for the work-site and give your name, telephone number, location and nature of the incident (if known) to the operator and ensure the emergency personnel have a copy of the MSDS.
5. All spills should be brought to the attention of company management. Inform them of the nature of the spill, location, involvement of personnel, telephone number etc. Follow the Emergency Reporting Guide for further information.
6. Follow the guidelines of the MSDS sheet for clean up. Wear appropriate personal protective equipment.
7. Post warning signs and/or tape off the area to prevent the spread of contamination.
8. Personnel involved shall wait outside the contaminated area, in the immediate vicinity, for the arrival of appropriate emergency personnel.
9. Call your employer, CANUTEC, and Manitoba Conservation(numbers are listed on the Emergency Phone Number list).

Let them know:

- 1. Your name and number**
- 2. Location of the accident**
- 3. Type of emergency**
- 4. Name of products involved**
- 5. The estimated amount of product that has leaked out**

10. Assist any emergency personnel in whatever manner necessary, keeping in mind your own safety.

Waste Oil Accidental Fire Procedure

Always Read MSDS before Working with Waste Oil

1. If a spill has occurred that has the potential to start a fire, follow the guidelines set out for spill procedures. If the spill becomes unsafe then follow the procedures for fire.
2. Always remove yourself and others from the area, get to a safe point upwind.
3. Assist any injured personnel and preform first aid if necessary, always keep in mind your own safety. Follow MSDS for proper first aid procedures.
4. If fire is extinguishable, extinguish upwind with a dry chemical extinguisher. Refer to MSDS for further information.
5. If you are not able to extinguish the fire, immediately call 911, let fire dispatch know the nature of the incident and that waste oil is involved. If the fire is due to arson then report the incident to police, follow procedure set out by police on this matter.
6. Always insure that all personnel stay clear of the area and do not come in contact with the fumes and smoke released from the fire.
7. Report all waste oil fires to appropriate personnel, this includes your employer, CANUTEC, and Manitoba Conservation(numbers are located on the Emergency Phone Number list)
Let them know:
 - 1. Your name and number**
 - 2. Location of the accident**
 - 3. Type of emergency**
 - 4. Name of products involved**
 - 5. The estimated amount of product is burning and the estimated amount that has the potential to burn**
8. Assist any emergency personnel in whatever manner necessary, keeping in mind your own safety.
